Charter School Board Governance Playbook

The Colorado League of Charter Schools has developed a [Charter School Board Governance Playbook](#) — a comprehensive, [240-page resource](#) designed to strengthen board leadership, improve oversight, and navigate the unique challenges of charter governance.

Alongside the playbook, the League has revamped its free, asynchronous, and publicly available Charter School Board Training Modules, which will soon be available on the League's website.

Policy Pulse: What's Happening Nationally

As of October 1, 2025, the federal government entered a partial shutdown, and while many core Department of Education functions have been paused, some grant-related operations remain intact. ([Education Week](#))



Here's what this means for charter schools and CSP subgrantees:

- **No new grant awards or discretionary activities** are being processed.
- Sub-grantees can still draw down funds from existing awards.
- Compliance monitoring and technical assistance may be paused or limited.
- Core formula funds (Title I, IDEA) remain available.

In Colorado, this means temporary delays in processing new CSP actions, including supplemental funding. Once operations resume, we'll share full guidance and next steps.
