2025 New/Replicating/Expanding Grant Open for Colorado Charter Schools

The Great Schools Colorado (CSP) 2025 New/Replicating/Expanding Grant Application is now open! This competitive opportunity offers up to \$2 million per subgrant over three years to support the launch, replication, or expansion of high-quality charter schools across Colorado. Eligible applicants must meet federal definitions and demonstrate readiness to open within 18 months. Applications are due by 5:00 p.m. (MT) May 12, 2025.

2025 Continuation Grant Application Now Open for Eligible Charter Schools

The Great Schools Colorado (CSP) 2025 Continuation Grant Application is now open as of April 4, 2025. This opportunity is exclusively for schools that previously received a CSP State Entities Grant through the Colorado Department of Education between 2018 and 2023. Eligible applicants must meet federal charter school definitions and demonstrate ongoing compliance and academic progress. The application deadline is May 2, 2025, at 5:00 p.m. (MT).
