# Forward into our next chapter

Welcome back to the school year!

Here at the League, our members' needs are what drive our efforts on a daily basis. We're proud of all we accomplished last year in working collectively to increase PPR, drive up facilities funding, and equalize funding for CSI schools. We also successfully beat back one of the most anti-charter bills in Colorado history. But we're not finished. We know the conditions to open, operate, and enroll students in Colorado remain challenging. We're working on our 2025 legislative agenda now, and our sister organization <a href="CLCS">CLCS</a> Action remains intently focused on upcoming elections.

Even with all these past wins, it's time to begin again. To start anew. We are constantly looking at additional ways to increase our value and enhance our support to you. As the new year kicks off, I wanted to share with you some of the ways that the League continues to up our game to better serve our schools, leaders, and communities. But if there are other topics or priorities you think we should be focused on, please don't hesitate to reach out and let us know.

**First, we're opening a new chapter of voice and member representation.** Starting in September, we're continuing with our <u>town hall series</u>, and we're planning regional meetings and school visits by our staff around the state. Reach out to schedule a visit from League staff or with your elected officials. With several new representatives, our <u>Member Council</u> also continues its great work of giving voice to the varied needs and interests of Colorado's collective charter school community.

Second, we continue to escalate our work in grassroots advocacy. Through our sister 501(c)4 organization <u>CLCS Action</u>, we are working to be more influential in local and state elections that are necessary to advance and defend quality charter schools, and we continue to build up momentum toward our legislative efforts by spending over \$2 for every \$1 received in membership dues. Imagine the force we could be if we were more effective at activating the 135,000+ families across the state currently benefiting from public charter schools.

Third, we're launching and continuing efforts to ensure that quality and opportunity for all students are at the heart of what we do. In line with our organizational principles, we're continuing with the implementation of our Member Quality Standards & Supports program. This initiative will elevate the urgency of quality amongst all of us. We are also waiting to find out whether the League will be chosen to administer the federal CSP program in Colorado. If we are awarded, we'll be opening up a new five-year chapter of accelerating growth and quality in the Colorado educational ecosystem.



But even with all these efforts aligned with our new <u>Strategic Plan</u>, it is time to ensure that our ongoing work continues to focus on you, our members, and how we can help you succeed in the areas that help you deliver on your mission.

If you're new to the League, welcome. If you're one of our long-standing members, thank you for your continued commitment. Here's to a standout 2024-25 school year. Please let us know how we can best serve you.

#### Defeat of Historic Anti-charter Bill

The League successfully beat back HB24-1363, which could have gutted the gains of the last 30 years.



# Quality, Choice & Accountability

Charter schools are tuition-free, public schools that have the flexibility to be innovative, entrepreneurial, self-governing, and yet are held accountable for student and operational performance. Open to all students, each of these independent public schools is different, increasing the variety of high-quality school choices available across Colorado.

From core knowledge, classical and early college curriculums to Montessori, language immersion and more, charter schools allow families to select the school that best fits their child's unique learning style. In exchange for operational freedom and flexibility, chartes are subject to higher levels of accountability.

## How it Works

The "charter" establishing each school is a contract detailing the school's mission, program, goals, students served, methods of assessment, and ways to measure success. The "charter" contract is between the charter school and the entity granting the charter (the authorizer). In Colorado, the authorizer is generally the local school district, but in some cases it is the state via the **Colorado Charter School Institute**.



In Colorado, charters are granted for a period of time, generally five years. At the end of the term, the authorizer may renew the school's contract. Charter schools are accountable to their authorizer—as well as to the students and families they serve—to produce positive academic results and adhere to the charter contract. They must also follow all state and federal public school laws.

Like traditional public schools, charters receive state funding based on a formula for each child enrolled in the school, referred to as Per-Pupil Revenue, or PPR. However, charter schools do not currently receive public funding for facilities.

# **Charter Facts**

Charter Schools are public schools. Colorado Charter Schools must be non-profit by law. Charter schools do not charge tuition. Charter schools use non-discriminatory enrollment practices. There are no test-in requirements to attend charter schools. Today, 265 public charter schools in Colorado serve over 135,000 students (2023-24). Charter school enrollment in Colorado is 15% of total public school enrollment in the state. Charter school students must take state assessments. Charter schools are subject to the federal Every Student Succeeds Act (ESSA). Charter schools serve a broad range of students, including: low-income students, racial and ethnic students of color, and students with disabilities or other special needs. Colorado charter schools are geographically dispersed across the state and serve urban, suburban and rural communities across 70 localities in the state. Charter school programs and academic designs are as diverse as the students they enroll. Some charters implement longer school days, while others implement curricula specifically designed for at-risk students, gifted children, pregnant/parenting teens, juvenile offenders, and more.

# Charter Successes: SPF Results

# Member Quality Standards & Supports

While autonomy and innovation have always been at the heart of what we do in the charter school space, accountability has been the other critical side of this equation. The encouraging news is that the state's **triennial report** has regularly shown charter school performance not only outpacing non-charter performance in aggregate but also for our state's most historically underserved student populations. Coming out of the pandemic, we are seeing **some of the largest positive deltas in charter vs non-charter performance we've ever seen**. But regardless of overall successes we still have work to do to hold ourselves accountable in specific areas, particularly when it comes to chronically underperforming schools.

The League launched the Member Quality Standards & Supports in 2023-24 to begin addressing this issue. The program creates standards against which we measure ourselves, while offering additional support services to help improve chronically underperforming charter schools. The core idea behind the program is to work proactively with these schools over a four-year timeline through intensive support and accountability, thereby increasing the value to students and the charter ecosystem overall. Current data indicates that less than ten percent of member charter schools will be impacted by this program.





The following are high-level components of the program.

#### **Performance Standards**

Those schools that are in the state's two lowest performance categories (Priority Improvement and Turnaround) and remain there persistently will be engaged in a quality improvement process with the League. The state's performance evaluation system is not perfect, but along with other measures this initial standard will be used to flag schools at risk. Schools may submit additional measures of student achievement to supplement the state's lowest tier performance categories.

#### **Enhanced Support**

The League already plays an essential role as a support organization to member schools, and in this case League staff will be providing enhanced, intensive support services for the most challenged schools. This will include initial assessment, review of additional information on quality, School Quality Reviews at subsidized or reduced rates, and then specific remediation on issues as co-determined within the process.

#### Accountability to All Schools

Beginning in the fall of 2023 with preliminary performance results, the League reached out to schools in the lowest tiers. When final SPF results are available each year, member schools that fall below that standard will be engaged further to determine a course of action. If significant underperformance persists for a period of more than 3-4 years, the League will engage with our Member Council to assess whether that school still qualifies for League membership and support.

#### The Importance of Quality for the Entire Sector

Initially, information from this program is not intended to go beyond League walls. Rather, as staff work to initiate the program it will focus on coming together to pull out of any downward cycles. The Member Council and League staff will play an active and ongoing role in the program's oversight and implementation to ensure that the program is implemented for the benefit of individual schools and the overall charter sector.
