The teacher will work closely with colleagues, parents, and students to foster a collaborative school environment. - Work collaboratively with partnering PE teacher, specials/electives teachers, core content teachers, special education teachers, educational assistants, and administration
- Participate in department, school, and parent meetings, including teacher coaching cycles
- Demonstrate preparation and skill in working with students from diverse cultural, economic and ability backgrounds
- Belief in maintaining the bar of educational equity for learners at every ability level
- Demonstrate professionalism and integrity
- Strong critical thinking skills and strategic problem solving skills
- Commitment to professional growth and personal development
- Prepare and co-lead annual Field Day events for students grades K-7.
