V. STATE TASK FORCES

Accountability: Passed during the 2023 legislative session, [H.B. 23-1241](#) creates a representative task force of 26-members that studies academic opportunities, inequities, promising practices in schools, and improvements to the accountability and accreditation system.

Discipline: The School Discipline Task Force was created as part of the 2023 legislative session ([S.B.23-029](#)) to study and make recommendations regarding school discipline policies and practices, State and Local discipline reporting requirements, and local engagement.

Finance: [Senate Bill 23-287](#) creates a Public School Finance Task Force for the purpose of examining and making recommendations concerning making the school finance formula simpler, less regressive, and more adequate, understandable, transparent, equitable and student-center.

Transportation: [SB23-094](#) creates a School Transportation Modernization Task Force to study the issues facing school transportation systems and use the study's findings to develop and recommend policies, laws, and rules to improve public school transportation across the state in order to better meet student needs and alleviate burdens on school districts.
